ORDER:

In the letter first read above the Commissioner for Development of Marketing and Director of Marketing has submitted proposals for the establishment of a Training Institute at Hyderabad for importing training to all cadres of employees of the Marketing Department, Farmers, Traders etc., In regard to the implementation of the Andhra Pradesh Markets Act., Markets Rules, Bye-Laws etc., as per the syllabus proposed by him at a cost of Rs. 5,38,600-00 as the Syllabus and qualifications prescribed for the training courses conducted by the Government of India are not generally suitable to the local requirements. He has proposed that the entire expenditure on the Training Institute may be met from the Central Market Fund.

2. Government have examined carefully the proposal of Commissioner for Development of Marketing and Director of Marketing and they hereby accorded sanction for the establishment of a training institute at Hyderabad with the following staff at a total cost of Rs. 5,38,600-00 (Rupees five lakhs thirty eight thousand and six hundred only) for the first year as per the details given in the Annexure –I to this order to impart training to the Marketing Departmental Personnel, Farmers, Traders etc., in regarding to the implementation of the Andhra Pradesh (Agriculture produce and Live Stock) Markets Act, Markets Rules Bye-Laws, Grading etc., as per the syllabus indicated in Annexure - II to this order:
